Introducing Social Equity Networks through a Public Trust for Community Wealth Building. The proposal for establishing a Public Trust is based on how a democratic government should operate with the inclusion of Civil Society. We invite the people and local enterprises to enhance our governance on solid fundamental principles proceeding with the holistic planning of our respective community needs.

In this video we will list the 8 basic steps to create your public foundation for Community Wealth Building.

What is a Public Trust?

Social Equity Networks is the Legal Umbrella providing the framework for protecting the people's interests. The Convention of Consent is the document to give a voice to the people. By creating the Public Foundation under the umbrella of the Public Trust Agreement, civil society can openly share their resources for community wealth building, which will prevent the mismanagement of public funds through Direct Participatory Democracy and through common understanding to reach an agreement, then we can write a new living constitution by the people and for the people.

This holistic approach is vital due to the present governing structure granting the rights of person to corporations. In effect this means that, corporations can utilize the charter of rights to protect their interests in court. The power granted to them has been abused and contributes to the extraction of human and natural resources

as introduced in “How Nations Fail.” Please view the reference links for the video “How Inequality Weakens Nations.”

Corporations are taking over all aspects of society; Lincoln anticipated this situation in 1864 when he said:

“Corporations have been enthroned and an era of corruption in high places will follow.”

What can we do to reverse this long-term domination of corporations over societies, who today are downsizing their labor forces due to advances in technology?

The first step that we need is to establish trust between the people and clearly define what the people want from our respective public administrations to avoid corporate influence over governments. To achieve this the community will need to be educated prior to creating Public Foundations for Community Wealth Building, which requires a constitution. Each society requires a constitution built on human rights. A constitution also defines the structure of an organization. For example, it establishes the framework and the principles as to how votes are conducted as well as how consensus can be reached amongst other things.

The goal of the Public Foundation is not limited to the following:

- Unite Local Enterprises to share knowledge, materials and human resources.
- Donate estates; tax exempt for use by the local community.
- Engage with community funded projects and regional initiatives

Listed below are the first steps to creating an equitable society, ensure accountability, trust and to bring clarity to the administrative and operational processes to benefit and empower our communities. The 8 basic steps to create the Public Trust are:

1. Sign the Convention of Consent
2. Elect Community Administrative Councils and Coordinators
3. Launch a Public Interest Research & Development Survey
4. Prioritize Projects for Community Wealth Building and Business Plan
5. Create a People’s Credit Union for Provincial and National trading
6. Begin the Public Trust implementation
7. Ratify the New Community Living Constitution
8. Initiate the operation of the Public Foundation

Through the Public Foundation, community funded projects will reduce our cost of living with the support and participation of the people, who are the official shareholders and final decision makers of our respective Public Foundations for Community Wealth Building.

The Public Trust sets the stage to regain control of our public affairs, to reduce bureaucracy as we proceed with the holistic planning of society. Civil society will be in a position to collectively develop programs and implement projects with a 100% transparency guarantee and full accountability. Direct democracy provides us with complete control and ability to monitor and protect our public funds as well as our human and natural resources.

The reasons for proposing a 100% transparency guarantee and full accountability are introduced through the reference links – How to find Canadian Municipal and Government Fraud where you will find revealing videos about the CAFR – the Comprehensive Annual Financial Report and the parallel financial system. Please pay close attention to these videos, they provide the reasons why people should be involved in public affairs and the key to avoid further corruption is, to write a constitution that will include Direct Democracy.

Existing communities can continue their administration and operation while projects are gradually handed over to the public foundation, where community coordinators are trained and supported as proposed by the Universal Alliance.

Coordinators operate with full accountability to the people, while the constitution is ratified through interconnected community foundations within a given province or state. Through our Public Foundation's Constitutional rights we will have the legal capacity at community level to ratify a new living constitution for our respective Province / State and National Levels of governance.

The Proposed Direct Democracy Blueprint introduces the holistic approach for building an equitable society in a more inclusive manner. We cannot stress the importance enough to study this blueprint – Turning Taxation into Dividends.
